

**THE SHELSLEYS PARISH COUNCIL**  
**Meeting held on 11th November at 7.00pm in the year 2014**

**4.1 Apologies:** Mr AN Champion sent his apologies in advance, arriving late.

**3.2 Declaration of Interest:** None

**4.3 Minutes:** The minutes of September 9th 2014 were signed as a true record.

The Clerk apologised for not being able to update the Parish Council website owing to WCC technical difficulties.

**4.5 Shelsley Walsh Hill Climb:**

Mr Simon Durling and Mr Mark Constanduros attended the meeting. A letter from the MAC in response to questions from the Parish Council was read out. In brief it explained that there is an increase in non Hill Climb events but these are social events. There is a close relationship with the Police and local Council and everyone is asked to leave slowly and quietly. The MAC supports local charities particularly St Andrew's it and also brings a lot of business to the community.

All parishioners can speak directly to MAC and in addition Cllr Hart acts as a liaison for the Parish Council who takes their views to the MAC and can get a timely response to any outstanding questions.

It was agreed that the Parish Council approach Highways to investigate the possibility of placing a speed restriction along the Shelsley Walsh road.

**4.6 Highways, Footpaths and Lengthsman:**

There was no verbal report from the Lengthsman. Rob Wilk's worksheets were examined and accepted.

Progress report at Leys, after correspondence with Highways there has been no further progress, clerk to investigate current situation.

Collapsed drain in Pard House Lane ref 6259878, this has been attended to by WCC however a stream flowing across the lane is thought to be affecting the road surface. Clerk to investigate.

The dislodged inspection cover at Kingswood junction has been rectified by WCC.

B4203 poor road surface, no notification of when the surface will be inspected.

**4.7 Planning:**

There was one outstanding planning application. To discuss 14/01106/FUL retrospective extension of car park at the Bridge Hotel to provide parking facilities for the hotel and adjoining camping and caravanning park. Councillors recommended approval.
