#### 3.3 Minutes:

The minutes of July 7th 2015 were signed as a true record.

# **Public Question Time:**

The Village Hall would like to be able to offer short bowling mat facilities and had approached the Parish Council for advice on funding. It was suggested that the VHMC could borrow a mat to see if the sport would be popular. In the mean time information on prices would be sought by the VHMC. It was also suggested that a direct request be made by the VHMC to the County Councillor who may be able to obtain funds.

# 3.5 Highways, Footpaths and Lengthsman:

There was no Lengthsman's Report, worksheets or invoice.

The Clerk read a long report on accidents on the B4203 all of which had occurred on stretches which have not been resurfaced. A copy will be sent to Highways and to Dr Pollock.

WCC has informs the Parish Council that a surface inspection will be carried out on the B4203.

The sign at Camp Lane has been straightened.

The suggestion that double yellow lines along Fetterlock's Lane by the quarry was not met with approval. The repositioning of the concrete blocks to deter parking and litter was greatly appreciated and the owner will be thanked.

A Highways newsletter with particular reference to grit bins and salt supplies has been received and was circulated to councilors.

## **3.6 Planning:** To report on MHDC decisions.

15/00296/S73 The Birche. Withdrawn.

15/00599/FUL Kingswood House. Withdrawn.

15/00694S/73 Stirt Farm approved.

An email had been received from the chairman of Stockton Parish Council alerting the Parish Council to a planning application for a solar farm at Stockton. Members were divided over the response to this but it was agreed no action should be taken other than thanking Stockton Parish Council for the information.

The Clerk in consultation with Councillors submitted the following planning details.

15/00694/S73 variation of conditions at The Birche. The Parish Council had no objection.

15/00823/FUL and 15/00824/LBC Southwood Farm (amendment and addition) recommend approval.

15/00694/S73 variation of conditions at Stirt Farm. Recommend approval.

Also, in consultation the PC recommends Sir Anthony Winnington, to continue as nominative trustee for The Shelsleys educational charity if he is willing to do so.

## 3.14 MAC Hill Climb:

The liaison Councillor Mr Bates had a meeting with the MAC during which the concerns of the Parish Council were raised. The MAC does its best to regulate noise and behaviour within the confines of the hill climb. Steps have been taken to get traffic into the venue much faster thereby leaving the lane clear for non hill climb traffic.

There is division locally about the noise of air displays. The tannoy system should not be used before 9am.

The MAC gives the utmost importance to complaints and is quick to respond to them but these must be in writing with the writer's name.

Any complaints received by the Parish Council will be raised by Councillor Bates with the MAC. The private agreement with the Winnington Estate remains private as do events not organised by the MAC. There are no plans to put private events on the website.
