5.5 District and County Councillors' reports:

5.6 Highways Footpaths and Lengthsman:

The Lengthsman's Report highlighted the need for clearing work on the old Stanford Bridge. Clerk to ascertain how long this would take. Worksheets including photographs for November and December were inspected and agreed.

Road sweeping and verges Camp Lane. MHDC sweeper cleaned mud from part of Camp Lane, now Clerk has requested entire lane to be swept. Lorries have caused damage to house verges. After a lengthy discussion, it was agreed that the Clerk will write to the resident explaining the Parish Council's position. There was no support for a request to make a passing place.

Progress reports.

Wheelie bin stickers 100 to be ordered for interested properties within the 30mph area.

Stirt lay by and illegal fly tipping. Fly tipping on private land is the owner's responsibility. No recent incidents of large scale tipping have occurred.

Dog Waste bin. Clerk to contact MHDC about siting of bins.

Pudford Lane grit bin. Bin 376 has been replaced by a new bin, the old bin has been reused, filled but not positioned by WCC in the position requested by the Parish Council.

5.7 Progress Reports:

Broadband. BDC is laying fibre cables in parts of the parish on behalf of BT but there was no substantive evidence of imminent connection. Councillor Metcalfe to enquire of Ste Ashton (WCC) for an update of the situation.

New Mill Bridge. The debris was removed from the bridge on 13th December.
