Public Question Time - Rock Parish Council Clerk attended the meeting to inform Cllrs about the WDFC Development Plan. The document was out for consultation and a piece of land in Clows Top was noted as a potential site for Travelling Showpeople. Many residents from the MHDC side of Clows Top attended a Rock PC meeting, some stated they knew nothing about the consultation. WFDC had asked PO to deliver leaflets to all houses in the DY14 postcode area. Rock PC were opposed to the site being used for Travelling Showpeople. Developers need to work together to resolve the issue of no mains sewer being in Clows Top. Clerk to Bayton PC advised this was being done, Clerk had attended meetings as a concerned resident. It was not obvious from leaflets delivered what sites were on the maps. Rock PC Clerk stated the Travelling Showpeople currently on land in Rock Parish were not being evicted, the landowner was happy for them to stay. Four people are resident on the site summer or winter. Rock PC had a Housing Needs Survey showing a need for bungalows in the Parish so elderly residents could downsize but stay in the area. It was agreed by all to keep in contact on this matter in the future. Bayton PC had sent an objection in to the consultation.
