1. To accept apologies for absence
2. **(a) Declarations of Interest: Councillors are reminded of the need to update their Register of Interests.**  
**(b) To declare any Disclosable Pecuniary Interests in items on the Agenda and their nature.**  
**(c) To declare any Other Disclosable Interests in items on the Agenda and their nature.
