Construction of a Solar Farm and battery energy storage system (BESS) facility together with all associated works, equipment, and necessary infrastructure.

This process will be in two parts:

ii) After the vote, the chair will prepare a draft response to Wychavon. The completed draft will be circulated to all councillors for comment, but I suggest that a team of three councillors including the chair should now be appointed to make the final decision on the contents of our decision. The likely final date for submissions is 6<sup>th</sup> April.
