Update on Speed Sign – Costs for posts yet to be billed / paid. J Newbury highlighted, in some instances new posts had not been erected, but extensions to existing posts.

Vehicle Activated Sign (VAS) has been in operation in Broadway. Over a 2 week period (Leamington Road), 17000 (Seventeen thousand) "hits" were recorded with the camera set at 31 / 32 mph. It was agreed, speed setting should probably be set more at 35mph.

VAS now moving to Childswickham. PC Greenhouse interested to see number of "hits" recorded, especially as related to the Roads Safety Team review referenced in the Agenda under "Childswickham".

Childswickham – One theft reported in Childswickham.

Broadway – Two further thefts in Broadway (Phillips Road / Bloxham Road).

Future of Local Policing / PACT – PC Greenhouse mentioned, funding cuts may impact PACT. However, impact as yet unknown.
