### 3) **Engagement of a Planning Consultant to Write an Objection Letter.**

#### a. **Background**

At Whittington Parish Council meeting which was held on 1 July 2015 the Council debated Application Number : W/15/01514/OU - <http://bit.ly/1eLuuSI> - Robert Hitchins Limited - Land Rear of Hill House, Swinesherd Lane, Spetchley - Proposal: Residential development (up to 300 dwellings), including infrastructure, ancillary facilities, open space, and landscaping. Access from the A4440 Swinesherd Way. All matters reserved.

**b. Whittington Parish Councils Resolution** was: Following debate it was moved, seconded and **RESOLVED** that the application be refused. Following further discussion it was moved, seconded and **RESOLVED** that due to the size of the development WPC would request an extension on the consultation date as there were many issues that needed to be addressed. It was agreed that the Clerk would enquire if it was plausible to engage a Planning Consultant to assist with a detailed response to support the objection.

**c. Planning Consultants Quotes.** Whittington Parish Council has received quotes from professional planning consultants who would be able to write a Holding Objection to Wychavon District Council on behalf of Whittington Parish.

**d. Engagement of Planning Consultant**
