## 7 Highways and Environment

- 7.1 To report on the Speeding Order for Spirehouse Lane
- 7.2 Additional bollards on the Old Birmingham Road corner with Monument Lane have been requested. To supply 6 matching bollards (one removable to allow access to the War Memorial) would cost approx £1300 plus installation. Is this something we should budget for next financial year. We would need WCC Highways department approval for this.
- 7.3 Following a tour of the parish Cllr Eales would propose the following i) that some orchids are planted in the cemetery now they are so well established on the verge
- ii) A resident who lives at 2710BR has asked whether trees could be planted on the verges outside 273 & 275. There are about five small verges here, three of which have small Rowen trees or Hollies. I assume the trees are partly to stop parking on the verge. I suggest we decide whether we would like to plant any trees along OBR & then consider whether this location is the most appropriate. I suggest this could be budgeted for next year if agreed. Suitable species can be purchased for around £20 £50 each but there would be an ongoing cost of planting, staking and loosening straps
