The Local Authorities and Police Crime Panels (Coronavirus) (Flexibility of Local Authority and Police Crime Panel Meetings) England and Wales Regulation 2020 came into force on 4th April 2020.

Broadly speaking the 2020 Regulations enable local councils to hold remote meetings (including by video and telephone conferencing) for a specified period until May 2021. They also remove the requirement to hold an Annual Meeting. The 2020 Regulations apply to local council meetings, committee and sub-committee meetings in England. (NSLC)
