a) 29 June 2017 A statement regarding the Vélo Birmingham cycle race

Councillor Dr Ken Pollock, Cabinet Member with responsibility for Economy and Infrastructure said:

"We continue to support the Velo Birmingham event. We are a council that supports cycling and we want to encourage cyclists to come to our beautiful county. However, we need to balance our support with listening to the concerns raised by our residents and by a number of Worcestershire businesses. An event of this scale inevitably means there would be road closures and we want to minimise the disruption caused.

"We have raised our concerns with the event organisers and following a series of meetings they have agreed to make changes to the previously proposed route through Worcestershire. The proposed new route would mean fewer road closures. It would be less disruptive and the route would avoid the areas in the west of the county from where most concerns arose.

"We will now begin the legal process to approve the road closures for the event and will continue to work with the organisers to mitigate the impact of those road closures on our residents and businesses."

b) AON Insurance Policy
