Minutes of the Annual Meeting of the Council held on Monday 17th May 2010 at 8pm in the Village Hall, Knightwick.

Mr R Attwood WCC Project Manager Highways and Bridges. A44 Teme Bridge.

Mr Attwood outlined the need for strengthening work to be done on the A44 Teme Bridge; As a result of the Selby rail crash some years ago, when a vehicle broke through the bridge protection and fell onto the rail track it has become necessary to ensure that all roadway protective barriers were capable of restraining vehicles in similar circumstances. It is therefore necessary to put crash-barriers along the footpath to protect the bridge parapet. (The clerk had already held two site meetings with WCC Highways – pressing to keep the footpath particularly having spent considerable funds to clear it.) Mr Atwood advised that the bridge structure dating from 1955 is similar to several that have experienced failures and he is legally bound to strengthen the side structures.

He was asked to consider two points;

a) The lack of a footpath at this point will require walkers either to walk a circuitous route via the Teme Footbridge or walk on the road itself at this point.

b) The crash-barriers will further restrict visibility at the junction of the A44 and B4197 – which is a difficult junction for emerging traffic onto the A44 already.

He would consider these points and return with detailed proposals to the council to show what must be done. The clerk was asked to follow up this matter to enable a resolution of the conflicting interests to be made.

The formal meeting commenced at 8.15pm.

In the absence of the chairman Cllr S Munday the vice-chairman Cllr S Twinberrow took the chair.

- 1. 1. Spoil Heap on A44 Lay-by Still in discussion with WCC Highways!! It is possible that it will be used as infill for some reconstruction work planned by the Bridges Engineering Manager.
- 2. Road/kerb by Knightwick Surgery This work will be done shortly.
- 3. Footpath on north side of A44 Teme Bridge; See discussion with the Project Engineer Public Items above.
- 4. EEC funding for footpaths This has not become available The current financial stringency means that only high priority projects will be funded.
- 5. Possible Park-and-Ride hard standing by the Bus Shelter on the A44 It maybe that this is an issue WCC Sustainable Schemes Team could help with; they have a small amount of funding to improve bus stop areas and have been asked if they could investigate and see if anything could be done.
- 6. Improve the surface of the footbridge over the Teme. Unlikely to be considered whilst the Highway's Budget is under pressure from 'potholes' etc.

Emergency Exit Signs are in place and the Fire Extinguishers are fully approved with an annual contract to re-inspect.
