

Section 3 – External Auditor Report and Certificate 2019/20

1 Respective responsibilities of the body and the auditor

2 External auditor report 2019/20

On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the authority:

- The AGAR was not accurately completed before submission for review. The minute reference for the approval of Section 1 and Section 2 is incorrect. However, the minutes provided confirm that Section 1 was approved prior to Section 2 in accordance with the Accounts and Audit Regulations 2015.
