KEMERTON PARISH PLAN

Summary

The purpose of the Parish Plan is to inform the local community, Parish Council and Local District Council of the wishes of the people of Kemerton. The Parish Council requested volunteers to establish a committee responsible for creating a Parish Plan. Once the Steering Committee was formed, it was agreed that the opinion of the village was required and this would be obtained through the distribution of a questionnaire. The response rate of the questionnaire was 58%, which is high and very encouraging.

The village of Kemerton is thought to be a beautiful place to live in, with a good community at the heart of a village with relatively good facilities. The villagers' main areas of concern relate to changes that could result in the loss of the natural beauty, the village shops, pub and churches.

The Action Plan proposes actions to address the key concerns identified by the questionnaire. This Action Plan should be addressed by the Parish Council and they should seek methods to facilitate implementation of the proposed actions. The District Council have indicated to the Committee that funds are more likely to be made available for projects if they are included in the Action Plan.

A joint meeting was held between the Steering Committee and the Parish Council on 28th January 2010 to agree the final version of the draft plan which would be then be presented to the Parish Council on 9th March and to a specially called meeting of all Kemerton residents on 11 March.

1.0 INTRODUCTION

1.1 THE INITIATIVE

1.1.1. In line with a Government initiative on Community Planning, Kemerton Parish Council decided early in September 2008, that there should to be a Parish Plan, produced by local residents, which would take account of the community's vision for the future and address matters of the greatest concern to the residents. To start the process the Council called for volunteers to form a Steering Committee with the objective of finding out what those wishes, and fears, were and to help the Council to formulate a Parish Plan.

1.2 THE PARISH

1.2.1. Kemerton is a village of some 192 dwellings housing 393 residents as at the last census in April 2001. The village lies to the south of Bredon Hill in the Cotswold Area of Outstanding Natural Beauty.



1.2.2. There is a village shop, a pub, a family butcher and two churches, one Anglican and one Roman Catholic. A village school no longer exists but a Primary school operates in nearby Overbury. There is a middle school in Ashton-under-Hill and a secondary school in Evesham, both accessible by school bus.

1.3 STEERING COMMITTEE

1.4 APPROACH TO THE PLAN

- 1.4.1. There were no councillors on the committee, but Mr Adrian Darby, Chairman of the Parish Council, did address the committee at one of its early meetings on future housing plans as visualised in the emerging South Worcestershire Joint Core Strategy and the West Midlands Regional Spatial Strategy. The committee also received a visit from Mr Andy Ford, Wychavon District Council, to discuss funding (no longer available from Government resources) and the process of producing, and the importance, of the Parish Plan.
- 1.4.2. The Steering Committee, meeting for the first time on 30th March 2009 in the Victoria Hall, decided that the best approach would be to circulate a tick-box style questionnaire to each household in the village calling for views on various aspects of village life. Answers were to be anonymous and, if sufficient replies were received, the results could be regarded as representative of the general wishes of the community as a whole and form the basis for a Parish Plan. The questionnaire would be broken down into the following sections:

Your Household - numbers of occupants, cars and parking Transport - how occupants get around.

Traffic - views on traffic problems

Crime - what crime worries people and what to do about it.

Leisure Activities - what facilities are used/required

Services - how people value the various services and utilities.

Planning and Environment - views on future developments

And Finally - a space to write views on village life.


1.6 RESULTS

- 1.6.1. Of the 188 questionnaires delivered, 109 completed copies were received back. The advice from Mr Andy Ford was that a 58% return was an excellent response. The committee then set about correlating the results to obtain a cross-section of resident's views from which it is hoped a feasible set of proposals for a Parish Plan can be drawn up and presented to the Parish Council for their consideration.
- 1.6.2. A general analysis of the replies to each section of the questionnaire, taking into account tick-box answers and supplementary comments, was then carried out by the committee. The answers to the tick-box questions are summarised in the form of percentages of the total number of replies received and are attached as an appendix to this report.

2.0 QUESTIONNAIRE SUMMARY


2.1 YOUR HOUSEHOLD

Question 1. The total number of people, including children, living in the 109 houses for which questionnaires were returned amounted to 229. The breakdown of numbers in each household, as illustrated in the chart below, showed that 33% of houses had single occupancy, 50% housed a couple and only the remaining 17% contained families of 3 or upwards.



- 1. Single Occupancy

Question 2. The breakdown by age and sex is shown graphically below. A marked absence of teen-aged children is evident, but an influx of 0-4 year olds is likely to fill that trough in ten years or so:



Question 3. 11% of respondents have lived in the village all their lives. 1% were new-comers, otherwise 20% have been in Kemerton for 1-5 years, 17% 6-15 years, 18% 16-25 years, 9% 26-30 years and 22% more than 31 years.

Question 4. 39% of respondents travel out of the village each day.

Question 5. There is an average of 1.58 cars per household. Based on there being 192 houses in the village, this would indicate a total of 303 cars to be accommodated.

Question 6. Of these cars, 26% are said to be garaged, 64% are kept on driveways and the remainder are parked on the road.

Question 7. 61% of respondents live in Upper Kemerton and 39% in Lower Kemerton.

2.2. TRANSPORT

Question 8. The car or van is the most common method of transport with 68% of respondents using a car or van to get to work, training or study. This is followed by a variety of transport uses, with 10% walking, 6% using the bus, 5% cycling, 4% using the school bus, 2% using a motorbike and 2% using the train.

Question 9. There was not a big response to this question but, of the total number of respondents, those who recorded difficulty in accessing the various services were hospital 8%, doctor 5%, dispensary 4%, dentist 4%, optician 4% and chiropodist 1%.

Question 10. The bus service is used by 11% of respondents on a weekly basis, 3% monthly and 12% occasionally.


Question 11. Of those who own cars, 38% of respondents would be willing to take part in a voluntary transport service within the village.

2.3. TRAFFIC

Question 12. 72% of respondents agreed that traffic speed through the centre of the village should be better controlled.

Question 13. 50% thought there was a problem with speeding elsewhere in the village.

Question 14. The breakdown of areas other than the High Street where respondents complained of speeding were:

Question 15. The safety of pavements for people with disabilities, wheelchairs or prams was described as poor by 51% of respondents, acceptable by 25%, unacceptable by 12% and good by 10%.

Question 16. Of those who identified the pavements as poor or unacceptable, 23% said the problem was opposite the shop due to cars parked on the pavement. This was followed by the High Street (outside Pear Tree Cottage) 12%, opposite the village hall and cross (due to hedges) 10%, Castle Hill (up to Hill Road) 6%, High Street (paving and tree roots) 6%, Kemerton to Overbury 4%, Bayliss Road 4%, and opposite the village hall and cross (poor paving) 4%. 27% of respondents also said the pavements in the village were generally too narrow and 2% said they were poorly lit.

Question 17. 75% of those who responded said they felt safe crossing the High Street.

Question 18. 72% said there is a problem with parking in the village.

2.3. TRAFFIC (cont)

Question 19. Of the 72% of respondents that said there was a problem with parking in the village, the two main areas identified as problems were outside the village hall (47%) and outside the village shop (34%). Other areas identified were Jobs Lane and Old Post Office Lane (6%), Church Lane (3%) and Kinsham Lane/High Street junction (2%). Various other locations such as Hill Road, Bayliss Road and Castle Hill summit also got a mention.

2.4. CRIME

Question 20. Burglary/Theft is by far the biggest crime-related concern in the village with 55% of respondents raising it as an issue. This is supported by 73% of respondents agreeing to a suggestion of a Neighbourhood Watch scheme The other main concern is the fouling of pavements with 27%, then vandalism with 8% and mugging, drunkenness and drug abuse all with less than 2%.

Question 21. 73% of respondents would like to see a Neighbourhood Watch scheme in their part of the village.


Question 22. Although 73% of respondents agreed to the implementation of a neighbourhood watch scheme only 59% said they would be willing to participate.

Question 23. Only 34% of respondents were aware of the name of the village policeman or the community support officer and only 31% knew how to contact them.

Question 24. 49% of respondents believed that arranging a weekly fixed time and location to meet the village policeman/community support officer was a good idea.

2.5 LEISURE ACTIVITIES

Question 25. Having a village children's playground was deemed the most popular request by 59% of respondents. Allotments were considered a good idea by 49% and a village playing field by 50%, Tennis courts and a general leisure park were favoured by 26% and 18% respectively:

2.5 LEISURE ACTIVITIES (cont)

Question 26. 34% of respondents said they would be willing to assist in the supervision of any playground or sports facility in the village.

Question 27. Additional activities suggested were, among others, a theatre club, table tennis, cycle safety, dance lessons, daytime socials, coffee mornings, walking groups, Pilates, yoga, a *boules* pitch, a wine club and bird watching.

Question 28. 42% of respondents said that they would like to see more use of Victoria Hall.

Question 29. Suggestions for more use of Victoria Hall covered most those mentioned in additional leisure activities above, plus a range of events such as more quizzes, craft sales, dinner club, drama groups, youth club - in fact, anything designed to bring the village together as a community. Parking was acknowledged as a problem for the hall and one respondent went as far as to suggest a new village hall, sited more appropriately, where sports and playground facilities could be provided nearby. Several respondents complained of the high cost of hiring the hall (cf. Overbury Hall) and suggested that prices should be reduced for use by local groups.

Question 30. With regard to footpaths and walks around the village, 77% of respondents said they used them and 60% thought they were well signposted. 50% felt that a map should be displayed in the centre of the village and 58% thought that a map should be made available for purchase. Only 37% of respondents regarded them as adequately maintained, whilst 30% did not.

2.6 SERVICES

Question 31. Respondents' usage of the various services in the village is shown in the following table:

12% of respondents said they used the Playschool for their children but this seems high in relation to the number of children in the age bracket of 0-4 in the village.

Question 32. The Post Office was shown to be used by respondents for a variety of purposes:



Question 35 Of respondents who have internet, 66% have Broadband.




- 1. Internet with Broadband (66%)

Question 36. 54% of the respondents who have broadband were not satisfied with the speed.

2.7 PLANNING AND ENVIRONMENT

Question 37. With 64% of respondents against the construction of new housing in Kemerton, any development within the village will have to contend with strong opposition.

Question 38. The following chart shows the percentage breakdown of the types of housing respondents felt should be built **if Kemerton has to accept some new housing**:



2.8 COMMUNICATIONS

Question 39. The notice board outside Victoria Hall is used to disseminate information, but only 15% of respondents admitted reading it regularly and 21% read it once a month.

Question 40. The village magazine (The Record) and the village shop are the most popular sources of information among respondents. The breakdown of where they generally receive news of what is going on in Kemerton is shown as follows:



- 1. Victoria Hall board (20%)
- 2. Bus shelter board (10%)
- 3. 'The Record' (30%)
- 4. Village Shop (33%)
- 5. Village pub (7%)

Question 41. Only 47% of respondents have ever attended a Parish Council meeting.

Question 42. 84% of respondents know the names of some of the Parish Councillors.

Question 43. Just under a quarter of respondents said that they would be willing to serve on the Parish Council.

Question 44. There was some negative feedback on the way the Parish Council keeps residents informed of the plans and activities of the Council. 9% of respondents believe it does it very well, 45% say it is quite good, while 35% say it is not very good. There have also been several comments on the lack of Parish Council elections.



3.0 PROPOSALS

3.0.1. Taking account of the answers to the Questionnaire, the Steering Committee puts forward the following proposals for consideration, and action where appropriate, by the Parish Council:

3.1 TRANSPORT

- 3.1.1. As 38% of respondents with cars are willing to take part in a voluntary transport service, a co-ordinator needs to be found to set up a voluntary transport service in the village. A scheme should be organised and widely publicised whereby those needing transport to the hospital, doctor appointments, dispensaries and so forth need only ring a coordinator to book transport .
- 3.1.2. To encourage people to walk more the Council should ensure that pavements in the village are maintained in good condition and that parking on them where passage for prams or invalid buggies is impeded should be discouraged in any way possible.

3.2 TRAFFIC

- 3.2.1. The speed of traffic, not only through the centre of the village, but also at other places identified in the questionnaire, must be better controlled and ways to achieve this should be discussed with the Highways Authority, the police and any other appropriate department to ensure a satisfactory solution. Signs, road markings, speed bumps and other such devices may impair the beauty of the village, but the safety of its residents must be regarded as paramount.
- 3.2.2. The problems created by parking in several places in the village, but in particular outside Victoria Hall, the shop and the pub in the High Street, attract a general complaint from 72% of respondents. True, maybe, that parking in the High Street helps to slow traffic down but it serves also to increase the risk of injury to pedestrians and cyclists. This problem should be addressed as a matter of priority and, as with 3.2.1 above, advice sought from others such as police and qualified traffic engineers from the Highways Authority.

3.3 CRIME

- 3.3.1. Setting up a neighbourhood watch scheme, or schemes, should be discussed with the Community Support Officer and a suitable coordinator chosen. Advice to residents on security matters and protection of their property should be included in the scheme.
- 3.2. To satisfy those complaining of fouling of pavements by dogs, the number, and siting of dog bins should be reviewed and increased if necessary.
- 3.3. A regular time and place for residents to meet the Community Support Officer should be arranged. For this scheme to work the details should be publicised as widely as possible.

3.4 LEISURE ACTIVITIES

- 3.4.1. A children's playground, allotments and a village playing field all featured highly in the wishes of those answering the questionnaire with 34% saying they would be willing to help supervise a playground or sports facility. The Council should look for possible sites for all of these activities. If the feasibility of any of them is established, a general village meeting should be arranged to solicit views on proposals and call for volunteers to run the facilities. Committees to set up and supervise each facility would be desirable.
- 3.4.2. The Council should commission a map of the village to show footpaths, and any other items of interest to a walker, and arrange sale of them through the village shop, pub or any other appropriate outlet. A map for general display somewhere in the centre of the village should also be considered. The footpaths themselves need to be checked regularly to ensure their good condition. 37% of respondents regarded them as adequately maintained.
- 3.4.3. 42% of respondents said they would like to see more use made of Victoria Hall, The Hall Committee should be approached to see if they could encourage more social events along the lines mentioned in the Leisure Activities section of the Questionnaire Summary. Any form of activity that brings the community together should be considered. Sub-committees could be formed where necessary. The Hall Committee should also be asked to review their hire rates in the light of criticism received from respondents.

3.5 SERVICES

- 3.5.1. Many residents expressed anxiety over the possibility that the shop/post office might close. Lack of parking in the vicinity of the shop is a problem, and any improvement in this would assist the shop and enhance its trade.
- 3.5.2. Similar worries were expressed over the loss of the pub and the Council should resist any application for change of use of both this and the shop. Villagers should be encouraged to use these amenities to maintain their viability.
- 3.5.3. Surface water drainage was the most criticised of the services with 54% of respondents rating it as 'poor'. The Council must continue to seek improvement in the maintenance of culverts and ditches.
- 3.5.4. Frequent power failures were another cause of discontent. The Council should write to the supplier expressing dissatisfaction over these power cuts, stressing in particular the dangers these present to the elderly in mid-winter through loss of heating systems. Residents should be encouraged to do likewise to reinforce the Council's position.
- 3.5.5. A written request should be made to the appropriate authority to request improvement to the speed of the Broadband.
- 3.5.6 As 34% of respondents expressed anxiety over poor snow clearance, a village contingency plan should be drawn up to cope with any heavy snowfall.

3.6 PLANNING AND ENVIRONMENT

- 3.6.1. The questionnaire found that a large number of respondents do not wish to have any new housing in the village. The finding is backed up by the level of support for a petition circulated in December 2009, which called for Kemerton's classification under the Joint Core Strategy to be revised, because it "is not a sustainable location for a significant number of new dwellings". The organisers visited every home in the village and obtained responses from 163 households. 98% of responses were in support of the petition. Any new development will have to contend with strong opposition to any development.
- 3.6.2. The Parish Council shall ensure that the village is kept informed regarding any potential development within the boundary, or close to, the village. By adopting this strategy the opinions of the village, whether in support or opposition, can be coordinated and effective in assuring that the decision reflects the wishes of the majority likely to be effected by any such development.

3.7 COMMUNICATION

- 3.7.1. Three quarters of the village have access to the internet and the Council should consider this as a method for disseminating information. A village website would be an asset in this respect and a volunteer should be sought, preferably a Council member, to set this up.
- 3.7.2. The notice board outside Victoria Hall is hardly ever read by residents, mainly due to its position. Unless anyone is going to the hall they seldom walk by there. Consideration should be given to re-siting the board, or making another one, in the vicinity of the shop. The cleanliness of the bus shelter has been criticized by some respondents and this may discourage residents from reading the existing notice board in there.
- 3.7.3. The Parish Council should publicise, by all means possible, the plans and activities they are proposing on a bi-annual basis, and should encourage villagers to attend council meetings, in particular the Annual Parish Meeting.
- 3.7.4. The Parish Council should respond to villagers' concern regarding the lack of elected Councillors.



5.0 Conclusions

- 5.1 The Steering Committee has had an excellent response to its questionnaire. This has enabled it to identify a number of widely-held concerns and put forward proposals which are representative of village opinion. The village is perceived as a very pleasant environment in which to live and as having a good community spirit. The villagers wish to ensure that this atmosphere is maintained and welcomes actions taken perhaps to enhance it. They are also committed to opposing any influences that would be to the detriment of the community.
- 5.2. The Parish Council should address the traffic and transportation issues in the village. With some coordination from the Parish Council, several of these issues could be dealt with by the villagers themselves. The problems with traffic should be addressed by the District Council and the appropriate authority.
- 5.3. Whilst crime is not a major problem, a neighbourhood watch scheme would be well supported by the community.
- 5.4. The villagers have requested that some forms of leisure activities should be made available in Kemerton. With careful consideration, cooperation from the District Council, local landowners and grants, where possible, these aspirations could be fulfilled. The proposals would require active involvement and commitment from the villagers in addition to assistance and financial support from the District Council or other external bodies.
- 5.5. There is anxiety regarding the possible loss of the village shop and pub. Ease of access is an important factor in their viability and measures to improve this should be addressed by the Parish Council as a matter of urgency. With regard to the infrastructure in Kemerton, more maintenance is required and the Parish Council should assist in pursuing this issue.
- 5.6. There would be considerable resistance to any development that might cause the loss of the village's unique charm and character. The Parish Council should ensure that it listens to public opinion and takes an active role in objecting to any proposals of further development within, or close to, the parish boundary..
- 5.7. The current methods of the Parish Council's communications within the village should also be reviewed. As many of the villagers have internet access, this could be a very effective way of disseminating information. The perception within the village is that the Parish Council could improve its methods of keeping villagers informed of its activities. The Parish Council should also address the concern regarding Council elections and how the Parish Plan Committee was formed.
