As we once more move into Spring none of us could have imagined that we would now be looking back at over 12 months of COVID restrictions. Thankfully the vaccine rollout has been quite remarkable and with cases coming down, we should all soon be able to look forward to things returning closer to normal. Whilst we are clearly not there yet the outlook is certainly looking brighter.

One benefit of staying local is that I have rediscovered some of the lovely walks that we have right on our doorstep, including along the River Avon and the lakes up by Throckmorton. The lakes in particular are well worth a visit if you haven't ventured that way. It is also good to see that the village field continues to be well used and we hope you are enjoying the amenities we have been able to provide. As a reminder these are detailed elsewhere in this newsletter.

You may be aware from previous newsletters of the plan to build a new town of up to 6,000 houses at Throckmorton together with associated infrastructure. This will have a profound effect on our small rural community and will see the creation of an urban conurbation almost the size of Evesham. The final public consultation for this will take place in the autumn and will be our last opportunity to express our views on the proposal before it is submitted to the Planning Inspector. We are continuing to work with neighbouring Parishes to express our objections to this and we will be in touch later this year to share details of our plans and what you can do, if like us, you are against this scheme. In the meantime, though we would welcome hearing from anyone who has expertise in the environmental, economic or social aspects of a scheme of this nature.

Finally, we are regularly asked who incidents or problems around the village should be reported to. This can be very confusing and so to help we have included a guide with this newsletter and we would encourage you to use this to report any issues you have. We have said this before but the more people report things the more likely it is that action will be taken.

Where your money goes

Each year, the parish council sets its 'Parish Precept' which is the portion of your council tax that is allocated to the Parish Council. In addition to this, over the last few years the Council has been allocated grants from housing developments and also been active in applying for grants. As a result, we have been able to put in place a number of improved and new facilities in the village.

Hill & Moor Parish Improvements since 2016

- Electricity Supply to the playing field
- Defibrillator purchase
- Phone box purchase and refurbishment
 - Outside water tap installation village hall
 - Perimeter walking path to the playing field
 - Basket swing
 - Timber Trail equipment
 - New tree planting

- 2 Memorial benches
- 3 Picnic benches and 2 other standard benches on the playing field
- Path lighting from car park to village hall steps
- Wild flower and bulb planting on the playing field
- New goal posts & mobile goal posts for juniors
- New flooring to the children's play area
- Extensions to the fence on the play area
 - Playing field fence rails
 - New mower for the playing field
 - New container for football kit storage
 - Provision of Smartwater Licences
 - Litter Picking Equipment Provision
 - Extra Dog bin provision
 - Christmas Tree Lights purchase and annual purchase of Christmas Tree
 - Football pitch scarification, seeding, draining, sanding and rolling

This year's parish precept has been increased due to rising costs. The Open Spaces budget appeared to be being almost entirely spent on maintenance, and had no spare capacity for the cost of mower fuel, so the Playing Field budget for 2021/22 was increased to account for this.

The Staffing budget was also increased to meet the cost of payments to the pension scheme. In addition: Admin Costs (for accounting software now being used) and the Asset Maintenance and Purchase Asset reserves. Overall, this results in an increase of £4.52 per year for a Band D household.
