He reported that the Playing Field is in a sorry state; on a recent visit it looks more like a wild-flower meadow. He

has asked Roger Thomas to mow it as a matter of urgency and also cut down the vegetation around the edges. He is meeting the Leigh and Bransford Badgers football Club officials to discuss the arrangements for the forthcoming football season on Wednesday and will report on this at the July meeting.
