

## BREDON PARISH COUNCIL

The Minutes of Bredon Parish Council Meeting held at Bredon Village Hall on Monday 14<sup>th</sup> September 2009 at 7.15pm.

In Attendance Ms Shields (Clerk) Cllr Hardman (County and District Councillor) Mr A Jaynes, Mrs H Newborough, Jane Bryant, Mr M Dunn and a parishioner.

Jane Bryant expressed her concern at the possibility of building on the area of land between Kinsham and Blenheim Drive, Bredon. Mrs Newborough thanked the council for the repair to the hole in the footway at Waterloo Way and brought to the attention of the council the footway between Blenheim drive and Station Road. Cllr Hardman informed the council that the footway is due to be resurfaced in this financial year. Mr Jaynes has concerns regarding public footpaths and their care. Footpaths are the responsibility of the Countryside Department at Worcestershire County Council.

Malcolm Dunn (BCPR) informed the council that the new design for the playing field will be presented at the public meeting to be held on the 21<sup>st</sup> September 2009.

## BREDON PARISH COUNCIL

Vegetation on the Highway in Watery Lane Kinsham has been cleared. The footways between Bredon and Kinsham and Bredon and Bredons Hardwick have been added to a list for siding out. The Junction of Kinsham Lane / B4079 the hedge has been added to the list for flailing. Continuation of footway between the two car parks in main road Bredon and an installation of a gravel path from the end of the foot way to the public footpath on the Eckington Road, is under investigation.

- e) W/09/01883/PN Bredon Hancocks First School Church Street, Bredon. Single storey extension to inner court yard to provide bathroom management area and cleaners store. Recommend approval.
- f) 09/02008/CU Lampitt House, Lampitt Lane, Bredons Norton, Tewkesbury, GL20 7HB  
Use of land for siting a log cabin for use as a holiday let/ Bed and Breakfast. This application does not comply with Local Plan policies ECON19 which specifically details what new tourist accommodation should be allowed outside development boundaries. We agree with the Cotswold Conservation Board that the new building does not conserve the character and appearance of the Cotswolds AONB as required under that policy. In addition it also fails to meet policy RES7 (b) in that the building proposed is new and not a conversion of existing and we therefore recommend refusal.
