5. Finance:

a) Approval of new expenditure -

Cllrs Nicoll and Kinghorn to instruct Lloyds to close the account and transfer the remaining balance of £4.20 to Unity Trust Bank

It was agreed that the Clerk's working hours from October should be 30 hours per month.

The Chairman confirmed that he would be retiring from the Parish Council at the end of the year. A formal letter confirming this would be issued to the Clerk and Councillors.

The opinion of the meeting was that the Parochial Church Council was responsible for the Churchyard Yew Hedge. Clerk instructed to write to the PCC on the matter

The Bushley Community Garden Hedge was deemed the responsibility of Bushley Village Hall and Cllr Kinghorn (Cllr responsible for BVH) to liaise on the issue

13. Issues at Oxhey Cottages

The damaged fence has been referred to WCC engineers for repair. Cllr Nicoll noted the water hydrant marker had also been demolished. Clerk to report the matter to Severn Trent Water

The blocked gully was reported to WCC and a works order has been raised to jet the gully
