This development requires a new entrance onto Church Street be made which would lead to removal of a proportion of natural stone wall and some on street parking in an area already congested. In addition it removes some employment land from Bredon village.
- c) W/09/00370/OU Lampitt house, Lampitt lane, Bredons Norton Replacement of plant hire business building with one detached dwelling. Recommend objection, as this application seems almost identical to submission 08/02811 which was withdrawn. The reasons are therefore the same as previously stated. The application is totally contrary to Wychavon policies. The development is outside the development boundary, inside an AONB and adjacent to a conservation Area and Protected Open space. In addition there would be loss of employment Land.
- d) W/09/00379/PP 1 Queensmead, Bredon. Two storey extension. Recommend objection. This development would be contrary to policies SUR1 and SUR6 in that it is not subservient to the original and does not enhance the original building or street scene.
- e) W/09/00195/PP Windrush, Mill End, Bredon, Tewkesbury, GL20 7LQ. Demolition of existing bungalow and replacement with a 2 storey part subterranean dwelling. Recommend for Approval
- f) W/09/00157/PP Homestead, Eckington Road, Bredons Norton, Tewkesbury, GL20 7EZ 2 Storey extension to rear, single storey porch to front elevations and garage conversion (door to be replaced by window). Recommend for Approval
