3642 APOLOGIES:

3643 WRITTEN REQUESTS FOR THE COUNCIL TO GRANT A DISPENSATION:  
From Cllr Mr M Hadley, regarding item 4, Roundhill Solar Farm – this was accepted & approved.

3644 The Chair opened the meeting and explained the structure and procedure for the meeting:  
i) Talk/presentation time limited to 20 minutes by Meeting Place (public relations consultants to JBM) and/or a representative of JBM.  
ii) Talk/presentation time limited to 20 minutes by representative(s) of RWSFOG.  
iii) Questions from the public limited to 40 minutes for all.

JBM had declined the above invitation and had requested a closed meeting with the PC; this was also declined as the council felt that there would be little further to be gained from a closed meeting, as they had examined and discussed the planning application in detail together with the door to door survey results at the PC mtg on 8<sup>th</sup> March.

Mr P Coathup representing RWSFOG made a statement opposing the application.

This was followed by statements from the members of the public (MOP), also opposing the application.

The Chair asked the MOP attending for a “show of hands”:

2. Does anyone oppose the application? – Everyone (unanimous).
