Update of the Speed Camera sub group

The Lengthsman (Ben Perry) and Councillors McDonagh and Latter, met to discuss the procurement of a new speed camera for Bushley on the 10th October and concluded the following:

- the foundations for both existing posts for the VAS cameras approaching the village from the A438 and from Bushley Green, are too weak so both need to be replaced (by Highways Dept), prior to fixing a new (heavier) camera
- the features the sub-group believe the new camera should have, include:
 - i) an indication of actual speed of approaching cars
 - ii) the ability to give a further message (eg "Slow Down")
 - iii) a solar panel supplementary charging capability
 - iv) ideally, Bluetooth enabled data read out showing speeding 'hits' by time of day

Separately, It is recommended that one additional battery for the existing Westcotec cameras should be procured, to allow the Lengthsman to routinely swap them around, thereby ensuring both cameras have fully charged batteries without interruption.

Authority for procurement of a single Westcotec compatible battery is now sought.

The Clerk has received confirmation that Highways will replace the VAS mounting posts - timescale to be confirmed. Once done, procurement selection can proceed.

Note: Longdon PC bought Elan City's product and they are reportedly pleased with it.

Consideration should be given to applying for grant funding for a second new camera.

In addition, the Lengthsman has provided site specific locations for the 2 hazard warning signs on the main A438 road, that also need to be replaced. Highways Dept, should be advised by the Clerk.
