Minutes Of Inkberrow Parish Council Meeting Held In The Pavilion, Sands Road. Wednesday 15th May 2024, Commencing At 7.30pm.

Democratic fifteen minutes public question time, the following points were raised:-

1. Planning application W/ 24/ 00633/ FUL. Stuart Davies expressed concern of the work/ live components of the planning application. The infringement of agricultural/ green area was noted, the size of the proposed building and its design were commented on. The issue of water and flooding, inadequate drainage, the clay soil and the water table height also raised concern. It was felt that 'need' for such units had not been demonstrated and the village of Holberrow Green did not have the infrastructure to support the sustainability criteria of live/ work units. The parish council were urged to refuse the application.

It was agreed that the parish council would review the submission. On previous minutes it was noted 'insufficient information' to make a recommendation. It was also questioned whether the public had adequately been notified at the time of the original planning permission.

It was agreed that Wychavon planning would be contacted directly with the concerns raised
