Minutes of the Parish Council Meeting held on Monday 14th October 2024 in West Malvern Village Hall at 7:30pm.

121/24 Public participation

To receive a report regarding contractual issues between Severn Trent Water and a group of residents:

Two residents attended the meeting and put forward plans to stage an operatic performance of Wagner's Ring cycle on August 25th next year. They asked if any funding would be available from the Parish Council. This would be considered at the November meeting.

The hedge on Lower Road was still to be cut and the container on Lower Road that had been the subject of planning enforcement was to be removed this month. There was a planning application for up to 200 houses at Cales Farm (Off Sayers Avenue) in North Malvern to be considered at the planning committee meeting on 16th October. Finally it was believed that the empty property on Nabs Pitch, West Malvern Road had been put up for sale. **District Cllr. John Raine** had not further information to add.
