The Minutes of Upper Arley Parish Council Meeting held on Tuesday 28th January 2025 at Shatterford Village Hall. The meeting commenced at 7.00 p.m.

Present: Chairman Cllr G Rickhuss, Cllr Mrs S Rickhuss, Cllr Mrs L Snodgrass, Cllr I Latimer JP and Cllr H Link.

- **1. Apologies:** Apologies were received from Vice Chairman Cllr Mrs T Lawley, Cllr J Lawley, Cllr S McLachlan and Cllr A Potter
- 2. Declarations of Interest: None.
- **3. Community Policing:** PCSO Marc Ginder gave the Police report. No issues to report in the Parish but he advised that there had been a spate of mowers being stolen in the surrounding areas so everyone should be vigilant. He recommended the use of ipad or android air tags to enable property to be traced in the event of theft.

The Clerk advised that a representative from the Police and Crime Commissioner's Office will be joining the March meeting to listen to Members concerns regarding Policing matters.
