- 3 **MINUTES:** The Minutes of the meeting held on 12th December 2024 were agreed to be a correct record. **Proposed:** Cllr Denyer, **Seconded:** Cllr Wheeler-Vine. Cllr Pengelly clarified that the daffodils were free but not the roses. Highway matters - Tutnall Close will contact Cllr Cooper later

- 4 **PROGRESS REPORTS FOR INFORMATION:**

Clerk:. none

Chairman: advised he had distributed the newsletter. The feedback had been positive, stating that there were some interesting articles. He has been digging at Broad Green to plant the rose bushes.

District Councillor: Cllr Whittaker advised that the District Council were appraised of the new national planning policy framework. The Government's proposed Devolution will mean the abolition of District Councils. Worcester County Council have replied that they agree to devolution and request postponement of County Council elections scheduled for May. NPPF - Bromsgrove's requirement for housing has gone up to 713 per annum. Re-organisation of refuse collection service. Had thought wheelie bin collection would work but vehicles were unreliable. Have been replacing vehicles with industry standard. Replace all diamond lift wheelie bins with cone lift ones. Environment Act 2021 - compelled local authorities to have a separate collection of food waste by March 2026 - hasn't started yet- no anaerobic facilities in Worcestershire as there is no funding. Decision re Foxlydiate Hotel has come through and been forwarded to Councillors.

County Councillor. Opposition groups in Worcestershire CC have been unhappy about devolution - no chance to consult residents. New political structure across County and

country. Parish Councils will have more responsibility. He urged everyone to read the White Paper regarding this. Budget meeting in February - money is being cut and going to metropolitan areas - mending pot holes etc. Application for anaerobic waste plant near Hindlip Hall.

Footpath Warden: Cllr Ryan explained he was in training. Meeting Patrick White next week.

Tree Warden: A lot of trees came down in the recent storms, has some more to plant.

Conservation Officer: none

Community Hall Representative: should be finishing extension for tables and chairs this month.
