### 62/25 Reports from other representatives

### To receive reports from County and District Councillors, and other representatives:

Cllr Raine gave brief update on County Council in the absence of Cllr McVey. No overall control so who will pair with who to have a majority – at a bit of an impasse at the present time. The District Council Annual Meeting will meet tomorrow night where further discussions will take place. And because Districts will be abolished, now is a good time for us to apply for any projects we'd like financial assistance with. Cllr Raine also touched briefly on the devolution of the Councils.

### 63/25 Minutes

*To consider for adoption the minutes of the last Parish Council meeting:* The minutes of the meeting held on 14<sup>th</sup> April were approved and were signed by the Chair.

Cllr Rouse said he was called upon as there was a problem with access to the site for the resurfacing machinery and they had to bring a hedge cutter to cut branches back. A conversation took place as to which councillor was responsible for the overseeing of the resurfacing work.

**Telephone Box (Dingle)** – Is still a bit of an eye sore. Cllr Harden will go and take a look. **Telephone Box (Village Hall).** It needs to be painted. Cllr Rouse thought David still had some glass for the phone box. Clerk to contact David to see if he has glass and paint.

## 66/25 Playing Fields and Open Spaces

The intention will be to get the other two sections done and apply for funding for both. Cllr Baxter raised the point of maybe looking at a bike gate or similar as there have been problems with mopeds and bikes speeding on the new, smooth surfaced track. Cllr Rouse said potentially it could be a problem for insurance purposes if someone hit a bike gate. A conversation around speed bumps, speed signs and channelling water from the track (the water would naturally drain into the play area). A brief conversation around Madresfield woods and excessive coppicing; this isn't within our Parish.

It was confirmed the grant needs to be applied for (for both sections on the path). Clerk to action.

Chains for the swings: Cllr Baxter said the quote she had was for £200 to replace the chains/£150 to replace with ropes (the latter was dismissed). Cllr Rouse to take a look.

Zip wire end stop. It looks perfectly fine – it's the Wickstead platform which is too high. Cllr Baxter to call Wickstead.

Circular Green bench around the tree. It's very wonky because the soil underneath it is being washed away, which is causing metal distress. Remedial work. Cllr Baxter will take some pictures and get a quote. Cllr Rouse suggested we put it on the grant application.

Burnt BBQ Table – Cllr Baxter to get a quote from Paul.

Have we received any CIL money through from Adelaide House. The answer is no, not yet. It will probably come through later this year. Clerk to check. Cllr Rouse asked if any grant money could be available for

the outdoor centre. Cllr Raine thought there would be. (To be noted. Cllr Turner passed the key for 'Laurie's Bench' to the Clerk).

**67/25 Allotments & Community Woodland** Cllr Turner confirmed that he and the Clerk have got a walk around with the Allotment Association this coming Monday. The clerk updated everyone concerning a micro digger and plot 32a. The plot tenant will make good the main path and the area above her allotment.

BBQ – Cllr Harnden to give Paul another nudge for the quote.

Cllr Sanoon asked the question whether the allotments are charged water rates – it's the Parish Council who pay. Water rates along with skip hire – the prices are rising. When were/are the rates increased? The question to be asked next Monday. What is the skip actually used for? Again to be raised next Monday. Could the Parish buy bulk compost bins.

The gully by the post box is still causing problems for cars – so any spare tar from the pathway resurfacing would be helpful.
