- 6. Highways matters
 - a. It was noted that the Parish Council were notified on the day of closure of the A422 between Appletree Lane and Dormston Lane for 'emergency surface dressing'. It was also noted that diversion routes have to be the same class of road, hence diversions are often longer than following the shortest route.
 - b. It was noted that the potholes on A422 near Holberrow Green junction were reported twice and repaired
 - c. #73540 Pothole report was noted. The road surface on Appletree Lane outside Little Nobury Farm has been assessed and orders raised for the necessary repairs.
 - d. The Fly Tipping on back of Churchway Piece from the Tuer Way had been reported Environmental / fly tipping NGp102439 and removed.
 - e. #73538 The road subsidence on Church Hill / Priory Piece Lane was noted that an Inspector has visited and reported no safety issues.

- f. #73536 Deterioration of verges Stockwood Lane to Alcester Road (Pinhills) was noted. It has been referred to Highways engineering who are looking into the possibility of applying bollards / verge masters or lining at the location.
- g. A water leak on Earls Common Road between Sands Road and A422 was raised and should be reported to Severn Trent.

- h. It was reported that the 'Inkberrow' village sign (at the Worcester end on the A422) is missing, report to WCC.

- i. It was reported there are raised paving slabs in Malthouse Crescent Action PG
- **j.** Illegal parking on Stockwood Lane at school drop off and collection continues. Reported to enforcement by a local resident.
- **k.** Speeding in Holberrow Green was noted and the meeting advised that this had been reported to the Police who would consider speed bars and the matter has been raised to the Senior Traffic Management Advisor. The Parish Council were also looking at installing a VAS sign which would also help with data collection of speeds through the village.

7. Lengthsman activities

There is a branch obscuring the VAS sign on the Sands Road end of village. The seat on the A422 just up from the school (on the opposite side) needed weeds strimming from around it).

It was noted that AA Salt hold a spraying licence and AA Salt to add verge on Ramble Close to mowing schedule.

8. BES Solar Farm

It was raised that the planning application W/23/00270/FUL may have been reopened for further comments. It was questioned if the Parish Council had been advised by Wychavon District Council. It was reported that the closing date for comment is 31st May 2025. It was agreed that the Clerk would contact Wychavon District Council for verification. If a formal application has been submitted and requires a response then the Parish Council would request an extension to the 30th of June and consider holding an extraordinary meeting. The Clerk was asked to request a summary document from Wychavon to highlight the changes from the first application to this one.

It was acknowledged that there is a backlog in process Planning Applications, due to volume attributed to a pending price increase, Bank Holidays and other unavoidable instances. WDC staff are working hard to clear the backlog.
