Democratic 15 minutes Public Question Time

- a. Issues surrounding the perceived speeding of vehicles along Withybed Lane were raised. Residents have reported receiving abuse from drivers. It was reported that there are no 30 mph signs outside of Ross Crescent and it was thought that drivers could believe the speed limit is 60 mph as you exit Ross Crescent. The Police have apparently been advised but were reported as 'not interested'.
- b. It was also reported that the construction work in Broadclose Lane was excessively noisy and work was commencing at 7.00 am. Some larger construction lorries are having to turn round in Ross Crescent before returning to Broadclose Lane to gain access it was also reported that the road has been damaged by metal caterpillar vehicles.
- c. It was reported that mature hedgerow had been removed and a fence erected at Withyfields development site and it was believed that approval to do so was still pending and this removal was not authorised.

 Robin (Chair) advised those attending that PG (Clerk) had already discussed the Withyfield development with the Planning Officer who was working with the Enforcement Officer. Those in attendance were advised they should raise any matters with Frances Fleming
- Apologies received from David Hunter, Jane Neal, Chris Burdett and Paula Gittoes Anthony Hopkins was absent.

(Men's Shed received a prize of £250 from Diageo for their design of a 'buddy' bench which will pay for the bench)
- d. Item (e) DH to complete the Survey on behalf of IPC Action DH
- e. Item (n) Withyfields Development. It was agreed that the Clerk would continue to liaise with the Planning Dept and the Kendrick Site Manager to reduce any further difficulties
- f. Robin Lunn to liaise with Anthony Hopkins regarding the Horticultural Show and timing of presentations.
