Draft Minutes of Mamble Parish Council meeting held in Mamble Village Hall on Thursday 11th September 2025 at 7pm.

- **2. Declarations of Interest:** Dispensation has been granted to Cllr. Bunn at each meeting for a Declaration of Pecuniary Interest, to enable participation in all discussions relating to the 'Lengthsman'.
- **3. Suspension of the meeting for the Democratic 15 mins/Public Question Time:** Mr P Cotterill addressed the meeting with his concerns regarding the overgrown hedge around the land opposite the Sun & Slipper. Mr Cotterill provided recent photographs of branches that have come over and blocked the footpath, which the Chairman said he was aware of. Mr Cotterill and Councillors had a productive discussion relating to all hedges in the parish that need attention.
