Minutes of the Parish Council Meeting held on Monday 13th June 2016 in the Fisher Hall.

73/16 Apologies

74/16 Interests

76/15 Reports from other representatives

To receive reports from County and District Councillors, Malvern Hills Conservators, Tree and Footpaths Wardens and other representatives:

Mr Charles Penn (Malvern Hills Conservators) reported that there was a pilot scheme being undertaken involving a landrover ferrying those with limited mobility to the Worcestershire Beacon. There was also an off road mobility scooter available for hire at the Wyche café.

A tender process was under way for the refurbishment of St Ann's Well café.

The Conservators were currently reviewing their pension fund and were investigating a possible rebranding.

Finally councillors expressed concern that many cyclists were straying from bridleways and Mr Penn agreed.

District Clir. Julian Roskams had forwarded a report to the Clerk. It had been proposed by the district councils of Wychavon, Worcester, and Malvern Hills) to put the Joint Waste Procurement out for tender and several expressions of interest had already been received. However, following the May elections, the control of Worcester has changed and they have now withdrawn from the tender process. Malvern and Wychavon will continue the process alone.

78/16 Progress Reports and other matters arising from the minutes

A second public meeting to discuss the future of the Brewers Arms had been held on 19th May. A new tenant had been appointed by the brewery and had attended the meeting where she was assured that residents would support her endeavours to make the pub a success. It was decided never the less to continue with plans for a buyout and the Steering Group had been tasked with preparing a business plan and to apply for grants to fund the group.

It was noted that the Malvern Hills Conservators were investigating the efficiency of drainage gullies, particularly on Westminster Bank.

A resident had experienced a flood in their property due in part to blocked gullies on WestMalvern Road and Old Hollow. The Chairman and Clerk were to inspect and report the WCC Highways. The Clerk confirmed that he had reported the broken stile near Blackheath Way, which was sited on the Herefordshire boundary.
