<b>84/17</b>	<p><b>Clerk's report:</b>  <u>New Homes Bonus</u> – currently available £4330.  <u>C2117 Badgers Hill to Handgate Lane, Sheriffs Lench(Temporary Closure) Order 2018</u>  <b>Proposed Order:</b> to close that part of C2117 Badgers Hill to Handgate Lane, Sheriffs Lench from its junction with U43606 Evesham Road to its junction with C2022 Fladbury Hill in order to facilitate Severn Trent works. <b>Alternative route:</b> C2022 Fladbury Hill, A44 Evesham Road, A44 Worcester Road, C2121 Chadbury Road, C2121 Lenchwick Lane, U43606 Hipton Hill, U43606 Evesham Road and vice versa.
