## PUBLIC QUESTION TIME

A parishioner highlighted problems with speeding along Claphill Lane and construction traffic driving through the village generally. More effort is required to stop this. In the interests of safety more signage is required. He suggested a Traffic Consultation takes place before any further housing developments occur.

Members of the public were oppose to the planning application 19/00375/OUT and were seeking support from The Parish Council.

Objections included:-

- 1. Traffic increase and speed
- 2. Sustainability Bus/cycle
- 3. Inadequate facilities no shop or doctors surgery
- 4. Flooding Issues
- 5. Transport Links None to Malvern
- 6. Parking Issues

Parishioners stated this application should not proceed as it was fundamentally flawed. This is supported by a petition containing over 200 signatures.
