## 6. Chairman's Report

I attended the development committee meeting to speak against the proposed development on the protected open space by the Village Hall. After finally getting my three minutes at 7.00pm with one exception, councillors present had no comment. Perhaps they were all tired from sitting there for five hours, but the one glimmer of hope was the one councillor who did speak asked that a one year limitation be placed on the approval. She felt if the project was not started in one year it should expire. The presumption being by then their planning rules will be in place and they will not likely to get planning after that time.

After sitting in chambers for over four hours I learned that there is no regard fro protected open space and although sustainability requirements are at the forefront of Wychavon August 2012 Planning update in actuality they are paying lip service to sustainability. Norton, as a 4b unsustainable Village by Wychavon's own definition should be the last place to see development on protected open space. There are no rules at the moment, and it appears to me that Wychavon is taking license to do what they want without regard to the Community or the P.C. They are also very keen to get the numbers of houses up to meet targets. As targets have not yet been determined, slapping houses in everywhere seems a very irresponsible strategy. We should be very afraid over the next year.

I received an email that a Pact meeting is due to be held on the 14<sup>th</sup> November at the home of Andy Clements (Harvington). I would like to nominate Councillor A. Hill to attend as our representative.
