The minutes of Sedgeberrow Parish Council meeting held at Sedgeberrow Village Hall on 17th March 2011 at 7.15pm.

1. Apologies:

No apologies were received.

2. Declaration Of Interests.

Cllrs were reminded to up date their declaration of interests

3. To Consider The Adoption Of The Minutes Of The Meeting Held On Thursday 13th January 2011.

The minutes having been previously circulated, were agreed as a true record and signed.

The meeting was closed.

Mr Parker informed the council that he was attending the Bus meeting to be held in Evesham on Monday 21st March. Enquired if the lights were left on around the school for security reasons, which they are.

7. To Discuss the Councils response to the Proposed Reduction in Subsidy to the Bus service.

The council, having taken into consideration parishioners comments, are very concerned at the proposed reduction in subsidy to the 540 bus servicing Sedgeberrow. The clerk will respond as suggested by the council. The Chairman had attended meetings held in Broadway hosted by Cllr Eyre.

Questionnaires have to be returned by the 1^{st} April, conclusions will be assessed by the County Council before tenders go out to service providers in July. The effects will not take place until September.

Many parishioners have been confused by some of the questions in the questionnaire and are concerned that it is not designed to facilitate those in rural areas where the bus is their only form of transport.

The chairman will display the notice of the meeting to be held on the 21st March in Evesham.

The concessionary bus scheme is to be run by the county council from 1st April 2011 and may only be used after 9.30am, this may cause problems for many rural users, for example the only bus for Cheltenham leaves Sedgeberrow at 9.13am, however once the chairman highlighted this to the county council, they agreed that Sedgeberrow residents could use their pass on the 9.13am service.

14. Items For Future Agenda and Councillor Reports.

The Chairman had attended The Worcs Area CALC meeting on the 3rd March where the Worcestershire Agreement, replacing the Worcestershire Charter, was explained, it was hoped to have this up and running by July, however with the elections in May it was suggested that the date be revised to accommodate new councillors.

The Chairman had attended the debriefing meeting of the Wychavon Parish Games, due to lack of competitors, the Games had run at a loss of £270.87, the organisers were actively trying to encourage more parishes to enter but the cost of entry would not be increased for this year.

Cllr Hunt had attended the recent PACT meeting and the Mobile Police Station would be in Sedgeberrow on 19th May 10.00-1.00 and 11th August 1.00-3.00pm. A recent questionnaire had highlighted the problem of parking outside the school; the police would be looking into this.

The flood group had approached households that had been flooded regarding their experience of insurance claims and re insuring properties, three require help with insurance. The group will compile information on the best insurers.

Cllrs Barclay and Tebbutt announced their intention not to stand for re-election in May, the Chairman thanked them for their contribution to the council.
