1. Apologies for Absence.

Apologies were received and accepted from Cllr Slater.

Non-material amendment to permission W/06/02022/PP for change of flat roof to pitched roof on front elevation; change 1 no. window to 2 no. windows at ground floor level to front elevation; Dormer windows to be changed to doors with Juliet balconies & pitched roof to dormers instead of flat roofs; Change 1 set of French doors into a window at ground floor level; Remove proposed roof light to extension. No objection.

(III) W/02723 23 New Street, Childswickham. Demolish existing utility & WC and construct new conservatory (revised scheme). No objection.
