- 19/00745 Shelton Farm, Lower End, Great Comberton new vehicular access off Pershore Road and associated change of use of land from agriculture to domestic drive – awaiting decision by WDC
- 19/00761 Land adj. to The Birches 4-bedroom dwelling house and separate tractor shed discussion took place, and whilst there were no objections to the proposal it was agreed that we ask for the dividing hedge between the site and Little Orchard to be retained, as well as the walnut tree in the front hedge. Finally a condition that all works related vehicles and materials be kept within the curtilage of the property
- 19/00492 Tibbetts Farm, Russell Street construction of 3-bedroom dwelling *Cllr Collingwood* took no part in this discussion lengthy discussion ensued, and whilst the dwelling house would fall within the settlement boundary, the drive and garden did not. It was agreed that there were already 10 dwellings within a 10-15 metre stretch of road, along with an overdevelopment of the existing site. It was agreed that we ask the planning officer to make a site visit, in particular to see the impact the development was having on the setting of an historic farm and house
