- a) Lengthsman areas requiring attention:
 - The clerk to ask the LM to strim the footpath leading to the church

- d) Footpaths
 - Damaged style in hands of CC clerk to chase
- e) Planning
 - (i) 16/01292 Barn House Partial conversion of garage to form utility and hall and construction of new dormer Approved by WDC
 - (ii) 16/01388- West End, Church Street External Insulation Approved

- h) Rooftops Housing Councillor Barnes has been working with Rooftops to ratify some of the issues in and around Hands Orchard:
 - Repairs to fencing IN the play area had been carried out but still awaiting repairs to fence OUTSIDE of the play area
 - Footpath from lay-by to Hands Orchard following several incidents where pedestrians had fallen, a request has been made to have the footpath re-surfaced
 - A request made for markings in the road in Hands Orchard to keep dropped kerb area clear of vehicles in order to enable less mobile clear access
- i) Allens Caravans Allens Caravans have advised that a planning application is shortly to be submitted for additional units / pitches. The parish council thought it would be sensible for Allens to organise an 'open event' to enable residents to see the plans and ask any questions. Allens had responded that this will be done. No other details available at the moment, and the planning application will be dealt with in the usual way by the parish council as and when it is received.
