Village Hall Update – Cllr King reported that the website www.candcvillagehall.org was up and working and would appreciate any comments. The village hall is nearing the end of the snagging and minor decorations stage of the refurbishment. The ground source heating is working well and the recent quiz night was a success.

Sheppey Play & Community Projects – The clerk reported that the LEADER part of the project was close to closing with all administration hopefully concluded before the end of January, the second part of the project was now underway.

As there were three parishioners present the meeting was closed for 10 minutes to discuss the recent issue of a planning application for affordable housing in Field Barn Lane (north west). This item will now be a subject of a Parish Meeting called at the Village Hall for Friday 16th December 2011 at 7:30pm.

8. COUNTY COUNCILLOR'S / DISTRICT COUNCILLOR'S REPORTS

WCC Cllr Eyre said she would forward a report in due course. She quickly mentioned her work on child services including adoption and extra funding for 2 year old nursery places for the disadvantaged. WCC has taken a lead role to accelerate broadband availability within the county, many manhole covers had been stolen, energy advice, reduction of 193 full time equivalent posts and gritting was expected to cope were also mentioned.

WDC Cllr McDonald had already circulated his report covering SWDP, Localism Bill, Broadband locally, and the funding for a new bridge in Evesham had been approved by HMG. This latter item would be closely monitored due to traffic implications around the Jubilee Bridge. He also asked the council to support moves to improve the Cotswold Line Service following the recent upgraded line to London now adding potential improved links to Birmingham. (This item was discussed separately below)

9. MATTERS ARISING

- a) Footpath 525 The clerk reported that the footpath warden had raised the subject with Fiona Argyll at WCC who indicated it was not a priority. The clerk will follow up with Fladbury PC.
- SOCIAL HOUSING note no consultation but planning application received.

A planning application has been received however there has been no public consultation with parishioners by the housing association. Hence the need for a Parish Meeting indicated above.

- 12. PARISH PLAN priority continues with Sheppey Play & Community Projects above.

13. PLANNING

- a) W/10/02601/CU Field off track to fisherman's car park Jubilee Bridge at Mill Bank Fladbury Support for Fladbury Parish Council and Cropthorne Mill owners together with a number of concerns have been filed and a decision is awaited. This decision is delayed pending further investigations with the Environmental Agency; however local objections cover many other aspects. Fladbury Parish Council is to approach Jack Hegarty (MD) and Gill Collin (Planning) at WDC due to the severe delays which are causing concerns over what the real objections are to this application rather than the entanglement with the technical aspects of the EA objection. The EA have recently requested a full blown topographical survey. WDC are trying to expedite this application but are wary of getting bogged down in further withdrawals/applications and appeals, and are trying to get the right decision first time. WDC have written to the agent indicating that they are going to proceed to refusal unless he indicates that he will satisfy EA survey request as quickly as possible which to date he has refused to do so. WDC have written to the agent indicating that they are going to proceed to determination unless he indicates that he will satisfy EA survey request as quickly as possible which to date he has refused to do.
- b) W/11/02031/CU Mr W Kimberley of Evesham re Land Junction with Main Rd, Field Barn Lane Change of use of land for storage and maintenance of fairground sweet stalls, swing boats and market stalls. Major Concerns and reservations were filed and permission has been granted with a number of conditions attached. (see circulation pack)
- c) W/11/02207/LUE Mr Wood, Smokey Farm, Smokey Lane Certificate of lawful use for occupation of dwelling in breach of condition 1 of planning permission PR 210/68, agricultural occupancy condition.- A major concern regarding splitting off of the property has been filed and permission has been granted.
- d) W/11/02224/PN Mr Strickland, Heath Works Proposed extension to industrial unit 3 & associated works Major concerns were filed and permission has been granted.
- e) W/11/02312/PN Village Hall Improve external lighting, additional car park lighting, installation of solar panels and ground source heating Support has been filed and permission has been granted.
- f) W/11/02345/PN Spa Housing Association Ltd –Erection of eight new affordable houses on land off Field Barn Lane (north west) WDC reply required within 21 days of 01/12/11 (i.e. 22/12/11) See Parish Meeting decision above.

South Worcestershire Development Plan Preferred Options Village and Town Consultation has been responded to with major concerns over the infrastructure deficiencies to support any more houses in the village especially on the north west Field Barn Lane site identified.
