Meeting of Cropthorne Parish Council held on Monday 1st March 2010 in the Village School 7:30pm.

1. APOLOGIES

2. DECLARATIONS OF INTEREST

Cllr Segar – Personal interest as a member of Village Hall Committee.

3. APPROVAL OF MINUTES

Cllr Meikle proposed, seconded by Cllr West, and the meeting agreed that the minutes for the meeting of 1st February 2010 be accepted and signed by Chair.

4. FLOODING - JULY 2007 - AFTERMATH

- a) WDC grant of £1,000 is still being considered (see below)
- b) Martin Cross WDC considers the extra drain at Patty's Farm to be a sensible proposal and the Environment Agency has indicated a licence will not be needed and Cllr Meikle will confirm. A tree may need to be removed requiring consent of WDC as it is in the conservation area and a planning application is expected to be required with funding available until March 2011.
- **5. POLICING** contact is PC Stuart Toms (08457 444888/03003 333000)

PC Toms reported that there had been a number of incidents of stolen batteries particularly from tractors.

CHARITIES – nothing was reported.

7. VILLAGE HALL – including Sheppey Play Project

Cllr King reported via the clerk that all the application paperwork had been submitted for the lottery top up grant and it was hoped all would proceed according to the plan of closing the hall by the end of March for 8 months of works to be completed.

V/chair Annis, Cllrs Segar, Meikle and West together with WCC Cllr Eyre visited the Broadway Activity Park and the South Littleton floodlit MUGA (Multi Use Games Area) and were impressed with both facilities. It was noted that the floodlighting was of a special Italian design in order to minimise light pollution and the MUGA kick-wall was in fact wise fencing rather than a solid wall. Two small pieces of play equipment for the Sheppey Play Project have already been sourced with existing funds and a two villages open evening for public consultation has been arranged for 6-9pm Thursday 18th March 2010 at the village hall before any plans are finalised.

The open evening is expected to address the main concerns of villagers/councillors and includes, but is not exhaustive, the following items: -

- 1 Demand/need in light of previous unused skateboard park experience
- 2 Screening and presentation being kept compact so as not to overfill the Sheppey
- 3 Lighting issues including timing of availability
- 4 Responsibility for post implementation costs insurance, inspection, maintenance & repairs
- 5 Reuse of existing skateboard area and enhancement of previous plans to screen it with trees
- 6 Shelter(s) nature, positioning etc

The meeting closed for 10 minutes to allow parishioners to address councillors.

8. COUNTY COUNCILLOR'S / DISTRICT COUNCILLOR'S REPORTS

The clerk reported that WCC Cllr Eyre had previously submitted and circulated a detailed three page report and only wished to update the status on Council Tax which was back up to 2.5% from 1.95% due to the belated Personal Home Care Bill which is being discussed at national level between the three main parties.

WDC Cllr McDonald has submitted a report for circulation and his monthly round-up report will be delivered to all villagers this week. He drew attention to Fladbury Parish Plan being adopted by WDC; to Gypsy & Traveller issues and the enforcement notices at Charlton; to 42 additional Wychavon sites (down from 123 then 62) mainly for transients using the M5 motorway; to expansion of the brown bin garden waste scheme. WDC council tax increase has been reduced from 2.5% to 1.96% following better collections from those originally claiming the 25% single adult occupier discount.

9. MATTERS ARISING

a) <u>Potential Newsletter</u> – Cllr King reported via the clerk that she would have Village Hall information for any proposed newsletter but there appeared to be little else of interest.

10. SOCIAL HOUSING

Chair proposed and the meeting agreed to send a letter to WDC asking how they wished to proceed following the recent rejection of all 14 sites by WCC (11), WDC (2) and the Parish Council (1). It was agreed that the Parish Council would review all the sites again at its next meeting in May; the clerk will circulate the map.

11. LENGTHSMAN

The clerk reported that two inspections had taken place in February and year-end billing has been sent to WCC. Only major potholes are being reported until the end of March due to county wide backlog following the exceptionally cold spell when a fuller inspection of all parish highways will be carried out by the clerk/lengthsman for a final winter catch all.

12. PARISH PLAN – priority continues with Sheppey Play Project above.

13. PLANNING
