## Wyre Piddle Parish Council

## Minutes of a Meeting of the Council held on Thursday 27th September, 2012 In the Village Hall, Wyre Piddle

Meeting commenced: 7.30 pm. Meeting ended: 8.25 pm.

- **1/9/12** Apologies for absence: CSO Simon Hall.
- 2/9/12 Members Disclosable Pecuniary interests and any changes to be notified to the Registers of Interests and Gifts & Hospitality: No changes to either register needed to be recorded.

## 3/9/12 Report of District and County Councillor.

Cllr Tucker reported that the South Worcestershire Development Plan (SWDP) targeted consultation was ending on 14<sup>th</sup> September and the next step in the process would include a report to be considered by the three District Councils in November. The objective was to have the SWDP ready for submission to the Secretary of State by the end of March, 2013.

The County Highways team was continuing to look at the possibility of fitting vehicle barriers to the Eastern Bridge and Cllr Tucker would be asking for further updates as to progress on the scheme.

A meeting of PACT had taken place and a new Chairman had been elected. Dates of future meetings would be circulated once the availability of the Policing team was known.

## 4/9/12 Closure of the Meeting to allow Parishioners Present to Speak on any Matter on the Agenda. The maximum time allowed per individual and other parochial matters for discussion to be at the discretion of the chairman. Questions which required a particular response to be submitted in writing.

No public questions had been received but the Clerk updated Members on the content of a written report that he had received from the local policing team.

Speed enforcement work had been carried out twice in July, although nothing had been done since then due to other commitments for the policing team. The results of the speeding enforcement work that had been undertaken were as follows:-

20<sup>th</sup> July between 11.45-13:30 6 drivers verbally warned, 3 drivers prosecuted with the highest speed recorded at 42mph.

9<sup>th</sup> July between 18:00-19:30 12 verbal warnings issued and 8 drivers prosecuted with the highest recorded speed being 45mph.

The Police would be undertaking further speeding enforcement work in the Village at the earliest opportunity.

Brian and Sue Price, from Rivermead, had agreed to take charge of one new Neighbourhood Watch area including Wyre Piddle, Upper Moor, Lower Moor and Hill. This will be forming over the next few months with a meeting with all the new members anticipated to take place in November in Wyre Piddle Village Hall.

## 5/9/12 Minutes of the Parish Council Meeting held on 19<sup>th</sup>July, 2012

The minutes of the meeting held on 19<sup>th</sup> July, 2012 had been previously circulated for approval by Members. No amendments were necessary and after being put to the vote it was resolved that the minutes be approved and signed by the Chairman as a correct record of that meeting.

## 7/9/12 Planning matters

## (a) <u>Current applications</u>

## **<u>12/01780</u>** Groesbeck, Chapel Lane, Wyre Piddle

Proposed extension of garage into separate dwelling to include single storey extension. (Retrospective).

Members raised several concerns in respect of this application

The change of use of the garage to create an independent residential unit in the rear garden of the existing semi-detached dwelling would result in a form and layout of development which would be unsympathetic to the context of the site and the adjoining residential development

It was also felt that the proposal would represent an unacceptable subdivision of the existing residential garden to create two smaller plots, which would represent a contrived development which would appear unduly cramped and would not reflect the established layout or character of this part of the village.

# <u>12/01792</u> Hill and Moor Landfill Site, Piddle Brook Lane, Wyre Piddle

Proposal to extend the existing composting operation at Hill and Moor Landfill Site and to bring the whole facility under a single development specific planning consent

Whilst the Parish Council supported this extension to the composting facility it was keen to see the development of the facility in Morton on Lugg in Herefordshire to ensure that the Hill and Moor Site was protected from an adverse increase intraffic emanating from any over capacity from the Herefordshire site.

## 8/9/12 Parish Council Member Vacancies

As no applications for the two current Council member vacancies had been received, the District Council had now given its consent to the vacancies being filled by the co-option process. The vacancies were being advertised on the Council's notice board and the Parish Website with a closing date for the receipt of any applications having been set as 31<sup>st</sup> October.
