# 5/9/13 Report of County Councillor Liz Tucker

Cllr Tucker brought members up to date on the progress of recent planning applications submitted to the District Council. The application for 41dwelllings on the Wyre Hill site was still being considered by officers. If officers indicated that they would be recommending approval of the application Cllr Tucker would ask for the application to be brought before the District Council's Planning Committee. It was most unlikely that the application would be successful in its present form

There had been increasing support for the construction of the Northern link Road to ease the pressure of traffic on both Pinvin crossroads and Wyre Hill.

A bridge design and costing study, jointly funded by the owners of Keytec 7 Business Park and Wychavon District Council, was currently being finalised which will help paint a realistic picture of the likely costs. There was to be joint meeting of Pinvin Ward Parishes Mon 14th Oct 7.30 at Throckmorton Village Hall to discuss local issues such as the Northern Link

The Eastern Bridge barrier scheme had been delayed due to problems with the supply of parts of the equipment, but installation of the road barrier was now scheduled for the end of October

# 7/9/13 Parish Council member vacancies

Following the advertisement of a vacancy for a parish councillor an application had been received from Mr Nigel Wood of Lyncroft, Wyre Hill. Following consideration of the application it was **unanimously resolved** that Mr Wood should be co-opted to serve as a Parish Council member

## 8/9/13 Community Events and Parish Games update

Carrie Oakley had submitted a comprehensive update report on Community events which is reproduced as follows:

"The Joined Up Entertainments team have had a bit of a break since the Fete but we are pleased to note that the joined up ethos that we seek to promote is at last filtering out as we note that on the 13th October St Anne's Church and the Village Hall Committee are joining up and holding a Harvest Supper in the Village Hall with local band FOG providing entertainment.

Further to this on the 30th October the Village Hall Committee are re-running last year's Joined Up Entertainments event and putting on a Wyre Piddle Picture Show in the Village Hall.

The Parish Council has been asked to make a donation to Fladbury First School for a couple of their current fundraisers as children from Wyre Piddle attend this school. The PC is unable to do so at the moment and it has been put to JUE that we may be in a position to help.

Bear in mind that we are an independent group of people (i.e. not the Parish Council) which has worked hard to put on events and make just enough money/or break even/ or make a loss with the hope of putting further events on.

We are not fundraisers. However, we do have some money at the moment following the success of the Fête back in the summer. We have made donations before such as one to the Breast Unit for Worcester Hospital and the provision of a Picnic Bench in Smith's Meadow. What we have done is asked the Fladbury PTA what their target figure is that they wish to raise and what they actively doing to fund raise so that we can consider the level of any donation the JUE team decides to make.

Future events - Remembrance **Sunday 10<sup>th</sup> November**– I have booked the Hotel and we intend to make, provide and serve Coffee and Cakes once again following the Act of Remembrance.

In December we will hold another Children's Christmas Party and we will have Christmas Carols and Mulled Wine on the Village Green on Christmas Eve.

**Village games update -**This is all still going really well and we are hoping for another top 5 finish, which for a small Parish like Wyre Piddle competing against 35 or so other Parishes is really quite something.

The Knock Out Events are being played with a great community spirit. And thinking just about Wyre Piddle, we have looked at the teams and we reckon that this year 50-60 different people will have participated".

Thanks were extended to Carrie both for her report and all of the hard work she had undertaken in respect of the organisation of the various events mentioned.
