17/01874/FUL Plot 5 Keytec East Business Park – Varden Rd, Pershore – Proposed building consisting of warehouse and offices – **Approved.** Approved by Planning Committee with no condition controlling noise despite a request from Parish Council. This was raised at Planning Committee by Cllr Tucker who received an unsatisfactory response from the Case Officer. Despite the Chairman indicating the issue of noise would be returned to, the application was approved and no further consideration of noise issues.

The Chairman thanked Carrie and Mike Oakley for presenting a planning update to the parish council and their report was approved.

55/18 County Councillor Report.

Worcestershire C.C. (WCC) are in the process of recruiting a new CEO-Public announcement expected Monday 4th December for approval on Thursday 7th December 2017. Once this is ratified WCC will move onto all the other vacancies.

WCC are in the process of reviewing their budgets.

Cllr Tucker gave a review of the Northern Link Exhibition -Update was that it all looks as though the Northern Link will go ahead even though some details may still need to be worked out.

The roundabout needs to be the sophisticated lights latest update is that WCC is still waiting for the correct information to be received by Persimmon Homes.

Cllr Tucker requested that the parish council informs her of any problems with the new bus service as problems have been experienced elsewhere. Wychavon D.C.- Aldi Application to committee on the 14th December – It is suggested that someone speaks at the planning committee on behalf of Wyre Piddle and Pinvin P.C. It was suggested that Carrie Oakley draft a response on behalf of Wyre Piddle P.C. to be forwarded to Pinvin P.C. WDC Strategy workshop has taken place – Change of age consultation being undertaken within local schools. Schools are concerned that any changes made within the school framework could affect results in the longer term.

Cllr Tucker also reported that in December she had been called to a meeting to discuss the Eastern Bridge barriers. The barriers are frequently being damaged or destroyed and the costs to WCC for this issue are becoming very costly. Cllr Tucker has agreed to report back to the next meeting of the parish council.

56/18 Community Events and Parish Games Update. Piddle Post.

The final Piddle Post has been written and published. It has run for 10 years with 102 editions. Writer and Editor Carrie Oakley gave thanks to all those that had supported this in every possible way. It is hoped that this role may be picked up by one or even two volunteers in the near future. The parish council requested that it be minuted that they expressed their thanks to Carrie and her team for their tireless work on this.

Joined up Entertainment.

Since Carrie and Ali stepped down the following have been ascertained:

- a joined up team of St Anne's Church and the W.I. provided the refreshments following The Act of Remembrance;
- a new team of younger mum's has picked up the Children's Christmas Party which is great and gives hope that they may also pick up the Easter Bonnet Parade or something similar;
- Mike and Carrie will continue to organise Christmas Carols on the Village Green; and
- Malcolm and the remaining team will take on the Fete in the Summer. So, as it stands, the annual calendar is still running.

WYCHAVON SPORT (Parish Games)

Wyre Piddle, now a medium sized Parish with 501 to 999 on the Electoral Roll, entered teams into all 15 events and accrued 133.5 points. In so doing, we came an impressive 4^{th} out of 25 Parishes in the 2017 Parish Games.

Eckington who had 134 points came 3rd - Broadway came 2nd with 150.5 and winning for the third year running, Bretforton who amassed an impressive 177.5 points.

In terms of points, we were also the best medium sized Parish, but that trophy was given to Hill and Moor who came 6^{th} with a120 points.

We however, were given the Award of Merit.

The Chairman asked that a vote of thanks be recorded to Carrie and Mike Oakley for all the work they have done over the years on the Piddle Post, Joined up Entertainment and Parish Games.
