4. District and County Councillors reports: Cllr Tucker reported that Highways had deemed the hedge on the corner of Back Way as a visibility issue. They would write to the resident and request that it be cut back. However, there were concerns as to whether or not the homeowner would comply. Cllr Stone was looking into a local solution. On planning matters, the planning officer was in the process of writing a report on Duffledown Farm.

HGV: There was no update on the HGV at Hill and Moor Meadows. Cllr Jeanes had sent a photo.

Cllrs Tucker, Betteridge and P. Jeanes had attended the meeting about the proposals at Throckmorton Airfield. It was the first of a series of regular meetings with local communities.

5. Parish Councillors reports:

- Cllr Stone reported that the streetlight at the entrance to the car park wasn't working.
- Cllr P. Jeanes reported that the ditch by the main road was causing problems again. There was sufficient water for tests to be carried out. Cllr Tucker would report this.
- Cllr P. Jeanes reported that the light on the village green had been done. The wooden posts would be done shortly. More posts might need to be bought.
- Cllr Saunders had procured some mole traps.
