- 3) Planning Applications & decisions To consider new planning applications
- a) W/16/01074/PP Applicant: Miss L Detheridge Location: 4 Church Terrace, Church Lane, Whittington, Worcester, WR5 2RD Description of Proposal: Erection of summer. It was moved, seconded and RESOLVED that the application be approved, subject to the proposal not adversely affecting neighbouring properties.

4) Internal Audit Report - Year End 2015/2016

The Clerk had circulated with the agenda the Mr Bradley's WPC Internal auditors report for the year ending 2016. The Council referred to the internal auditor's action plan on page 5. Reference **R1** - It was moved seconded and **RESOLVED** that the Clerk circulate purchase invoices/expense receipts to the Council for approval before payments are made.

R2 - S137 the available budget for 2015/2016 had not been calculated - Total on the register of electors for 2015/2016 was 519 x £7.36 = £3,819.84 this amount was the budget for 2015/2016.

Explanation of s137 Power of local authorities to incur expenditure for certain purposes not otherwise authorised.

(1)A local authority may, subject to the provisions of this section, incur expenditure which in their opinion is in the interests of, and will bring direct benefit to, their area or any part of it or all or some of its inhabitants, but a local authority shall not, by virtue of this subsection, incur any expenditure—

(a) for a purpose for which they are, either unconditionally or subject to any limitation or to the satisfaction of any condition, authorised or required to make any payment by or by virtue of any other enactment; nor

(b) unless the direct benefit accruing to their area or any part of it or to all or some of the inhabitants of their area will be commensurate with the expenditure to be incurred

Clerks Note - The Department for Communities and Local Government has confirmed that the appropriate sum for parish councils for the purposes of section 137 (4)(a) of the Local Government Act 1972 ("the 1972 Act") for 2016-2017 is £7.42.

R3 - S106 projects, it was noted that prior to the commencement of projects it would be good practice to carry out a risk assessment. This will help to determine what risks such projects could pose to the council and to consider appropriate controls to put in place.
