2010.14 Police Report – For Information.

This item was dealt with after item 2010.02 but is reported here.

PC Sean Wood reported some 85incidents (calls) on his patch over the last 3 months, but these included many originating from the M5. There were only 2 recorded crimes in Whittington during that period, a domestic assault and a burglary.

There had been a plague of shed break ins in his area (but none in Whittington) and he enjoined all to maintain good levels of personal and home security and a high state of vigilance.

He had been in contact with Whittington School and established a programme of visits (3-4 per term) where he had the chance to encourage good relations with pupils and their parents, including the need for care in dropping children off at the school - in which connection he had used enforcement against some offenders.

In his period of tenure there had been a drop in the levels of recorded crimes in 2009 compared to the same period in 2008, of around 39% over the months of April to December (inclusive).

He indicated the value of pro-active policing and encouraged parishioners to report any unusual occurrences as although sometimes innocent in themselves they had led to arrests in some instances.

The Chairman closed the meeting temporarily to allow public comment.

S. Brooker commented on the dangers of the A44/J7/and the B4084 with especial reference to speed limits and roundabout safety which the Council addressed subsequently by re-opening item 2010.7, when the meeting was reconvened

Councillor Adams suggested that in the light of comments and concerns it might be advisable to include County Councillor D. Prodger in correspondence and to invite him to attend a WPC meeting. It was agreed that he be invited, with D. Clee to the Parish Meeting in April - the Clerk was to advise details to Councillor Adams.

The meeting was reconvened and, with the consent of Members, Item 2010.7 q.v. was re-opened.

2010.07 Highways & Byways.

a. Highways Matters:

<u>General:</u> None. <u>M5 Noise:</u> None. Maintenance:

Works for the Lengthsman: None. Previous Matters: None raised.

New Matters: In the light of comments raised during the later "democratic period" the Chairman, with the consent of Members re-opened this item to resolve matters raised there.

"40" (mph) repeater signs on Whittington Road: The deficiency pointed out was agreed by Members and he Clerk was instructed to inform the Highway Authority, pointing out the excessive speeds and dangers to pedestrians using the pedestrian crossing, and the deleterious effect of speeding traffic on the local environment. Speed enforcement was also to be sought from the police.

"Lane Arrows" on roundabout at J7: It was suggested that lane arrows (left hand lane M5 North, centre lane Pershore B4084) and right hand Lane M5 South) be installed. The Clerk was instructed to request the Highway Authority to consider this (if necessary liaising with the Highways agency).

Roundabout markings at "Swan" roundabout: It was reported that the "give way" lines across the carriageways were wearing badly and required re-marking. The Clerk was to report this.

Traffic Management:

Previous Matters: None. New Matters: None.

b. Byways Matters:

<u>General:</u> The Clerk reported the plans for the 2010 Parish Improvement Programme (PIP), and that suggestions for work had been passed to the relevant Countryside Access Officer.

The suggestion that a right of way be established up Crookbarrow Hill had been rejected as it fell outside the remit of the PIP. Previous WCC investigations had failed to show any such right of way and if the matter was to be progressed an initiative would be needed from parishioners or other interested parties.

Bridleways: None. Footpaths: None.

2010.08 Training.

Members considered the provision of in-house training agreed that this be programmed for Tuesday 9th February. The Clerk was asked to make the necessary arrangements, liaising with the Chairman over the subject matter. Members were informed that CALC were again running training courses for Councillors but no-one sought to attend.

2010.09 Budget & Precept 2010-2011.

Members considered the Draft Budget sent out prior to the meeting, and the proposed precept of £6,200 representing an approx 3.5% increase based on the "Band D" equivalent. The budget and precept were agreed (MB/AL) without amendment.

2010.10 WCC Consultation on Waste Core Strategy.

The relevant letter and information were placed in the Correspondence File it being agreed (in view of the time limit) that Councillors should respond individually. The Clerk pointed out that the information could be accessed "on line" at the Worcestershire Hub.

2010.11 Wychavon Bursary 2009/2010.

Members considered nominations for the Wychavon Bursary and agreed that L.R. Wiltshire be nominated for a second time in view of his continued dedication to the Community and the Village Hall in Particular. In view of the shortage of time RAP undertook to provide the Clerk with a draft submission to the District Council.

2010.12 Adult Learning Classes.

After considering inception of WCC Adult Learning Classes in Whittington, Members did not feel that there was likely to be sufficient demand for them. It was therefore agreed that an item should be included in the entry to the Parish Magazine advising people of the availability of such courses and giving WCC contact details for those interested.

2010.13 District and County Councillors' Report – For Information.

County and District Councillor apologised for his late arrival and noted the alterations to the draft County Transport Structure plan which abandoned the dualling of the "Southern Link", but provided for the upgrading of the Ketch and Norton Roundabouts. He believed that the Whittington roundabout(s) should also be considered as they were already bottlenecks.

The concept of joint working between Councils was still under review and WDC had identified possible savings of approx £240k resulting therefrom. Environmental health services were the next candidate for joint working, probably out of Bromsgrove Council offices.

Snow conditions remained a problem some 1400 tonnes of salt had been delivered and many grit bins had been refilled.
