3. The meeting was adjourned for Progress Reports and also the Public Question Time, notes of which are appended to these minutes.

Before item 4 on the agenda the Chairman appraised Anthony Perry of the meeting that had previously taken place with the Landowners (7) to discuss the possible bunding of the brook which borders their properties. All attended with the exception of one. The six attendees agreed in principal to the bunding but it would obviously need further discussion. The seventh landowner stated that as their garden is elevated they were not flooded before so did not need the bunding at their property boundary.

Anthony Perry said that there is a flood defence scheme but costs have to be agreed. He outlined the national schemes but also said that smaller ones are not a priority. The local levy may be able to fund these. There is a fund available for Wickhamford but more funding is needed. This will not be easy to achieve and will take time, (2 years was mentioned). Surveys have to be completed i.e. Archaeology, Heritage etc. He also asked if Wickhamford would work together to help "fund" part of the project.

Councillor asked how long the local levy lasts for . The answer was possibly until mid next year. Anthony said he would arrange for someone to liaise with the landowners to agree the bunding proposal so the scheme could move forward to be costed. Clerk to email Anthony with a contact who would liaise with the landowners and Anthony's liaison contact who will in turn report back to the Parish Council.

Finally Anthony stated that although asked, insurance companies were not prepared to assist financially to any flood defence schemes.
