2. Formal request from Management Committee has been received requesting that PC takes over the management of hall with immediate effect but that Jane Jones and Jo Davenport are part of sub-committee- Agreed.

3. To consider quotation for ceiling painting/painting and walls- Deferred.

4. Cleaner- It was agreed to advertise in village for a cleaner for a minimum of 2 hours per week plus other agreed duties and to be flexible around bookings. Applicants should express their interest by contacting the clerk with 2 week closing date so that a site visit with Cllrs Davis and Smith can be arranged.

- 2. Wildflower planting- Clerk to contact Highways to arrange a site visit to amend locations.
- 3. Britain in Bloom- Removed from agenda until information received.
- 4. Land for village car parking- Cllr Appleby agreed to contact landowners and Cllr Smith also agreed to meet with them to discuss matter.
- 5. Bretforton Sports Club car park- At the time of the meeting, further information had not been received therefore deferred until March meeting. NB. Information subsequently came to light by Chairman.
- 6. Housing Needs Survey- Clerk confirmed that icard system had been agreed and contract signed with project commencing on 17th February 2020. Cllr Wright advised that this would have no bearing/has nothing to do with the current appeal for housing. Cllr Davis advised that there was a higher need for social housing that would normally be the case.
