- They have embarked on a recovery framework looking at communities and local economy, concentrating on resetting the business. ie. Getting staff back to original roles and back from remote working.
- Annual Council Meeting due to be held in May will now take place in July.
- For the period 15th May-22nd May 2020, there were no new deaths in Wychavon from Coronavirus.

ITEMS FOR DISCUSSION.

- 1. Memorial Hall- Playgroup have restarted on 8th June 2020, Chair and Vice-Chair carried out a health & safety check prior to re-opening. New chairs have arrived and old ones have been collected. Grant has been received from Wychavon. New sign is now in situ. Meeting will be arranged for hall committee to discuss plans going forward.
- 2. Wildflower planting- A number of inspections have been carried on the verges at Back Lane with regard to Giant Hogweed. Worcs CC green team have confirmed that there is no evidence of it. Lengthsman has confirmed that he will clear the verges at the appropriate time with a view to planting wildflowers.
- 3. Land for village car parking-Next agenda. Request report from Cllr Appleby before next meeting.
- 4. Bretforton Sports Club car park- Chair has assessed access to play area and believes that access is acceptable for purpose, Cllr Wright advised that grass in the play area and surrounding area is best so that area drains. Request that Ancient Oaks cuts back cherry tree interfering with zipwire at appropriate time.
- 5. Flood planning-Next agenda. Request a report from Cllr Smith before next meeting.
- 6. Speeding- Resident has raised a number of concerns regarding speeding. Clerk confirmed that she has asked Highways to look at VAS locations on Honeybourne Road and Main Street and contacted Cllr Adams regarding Community Speed Watch, both are waiting a

- response. Discussion took place about '20 is plenty' signs but it was agreed that they are not appropriate in many areas of the village.
- 7. Footpath-Policeman's Corner.It was agreed to ask Highways to meet to assess footpaths at Policemans Corner and Bucket Row as they are not fit for purpose.
- 8. New footpath-Recreation Ground- Chair suggested that councillors consider a path around rec ground so as to have a safe walking path for prams and dog walkers as well as runners. A plan has been produced for consideration, it may prevent walkers from walking across cricket pitch. Cllr Wright suggested making the most of the memorial trees with some kind of plaques visible when you walk by. Councillors were requested to look at the area on foot for the next meeting.
