REPORTS FOR INFORMATION.

Clerk:

- NALC's guidance on the return to face to face meetings- This matter was considered by councillors. At this time, the government guidelines state that virtual meetings must cease by 7th May 2021 and face to face meetings re-commence. NALC have made a number of suggestions regarding bringing forward May meetings and delaying June meeting until the situation is clearer. They have also provided information on how face to face meetings could run. This could include:
 - Councillors and the public arriving at different times, no paper to be used, cleaning of venue before and after meeting, public forum booked in advance to ensure numbers are within guidelines, questions presented in advance so that attendance is not necessary, an in and out door, seating spaced out and not facing each other. Cllr Hall proposed with a unanimous vote in favour to bring forward May meeting to Tuesday 4th May 2021 and to consider the amendment to the June meeting in April or May when the guidelines become clearer.
- Allotment take up for season commencing March 2021-All but one plot has be taken up for this year, 2 plots are now available and will be advertised firstly in Bretforton and then surrounding areas.

- 1. New footpath-Recreation Ground.- i. Clerk confirmed that she had presented the proposal to Wychavon Localism Panel on 8th March 2021and NHB funding has been approved. Chair and clerk will meet with contractor over next few weeks to finalise the details.
- 2. Provision of disabled play equipment- A proposed drawing has been received from Kompan, awaiting costings so that grants can be applied for and other companies considered.
- 3. Website- The new site has been populated with key information but now requires information to be added supplied by councillors, Cllr Cleveland and clerk will receive training on 15th March 2021 to manage site. Information about footpaths, allotments plots, speed watch will be added.
- 4. Newsletter- It was agreed to ask Cllr Grant to obtain prices and start newsletter before April meeting which needs to primarily promote website launch.
- 5. Non-public Footpaths-i. Put on newsletter to ask for interested residents in getting involved in project.
- **6.** Land at Littlebrook Nurseries.- Resident has met with Worcs CC and Worcs CC have confirmed that it is their land and that they will maintain it in future. The fence has been removed
- **7.** Speeding on B4035- Volunteers required to form speed watch, speed check will not be done until June at the earliest.
- **8.** The Cross-Posts- Work is now complete with posts in situ, suggested to contractors that posts could be removed but it was unanimously agreed to keep them.
