- Parking-Orchard Close. Enforcement have confirmed that they have made several visits and will make further visits over next few weeks.

ITEMS FOR DISCUSSION.

Allotments- Valuation of land has been carried out with a valuation received of £50k for land. Send letter to owner making an offer of £50k for land. It should be noted that the house and land is up for sale and no agreement will be received until the house is sold. Proposed by Cllr Wright. Seconded by Cllr Cleveland. All in favour.

Village Plan- Questionnaires to be handed out and hand delivered to all residents. Can be returned to Clerk, Chair or Post Office. Parish Plan to be put on next agenda.

Projects for Future. It was suggested by Chair and unanimously agreed that this should be deferred until new year as funds may be received for New Homes Bonus which would allow larger projects to be considered.

Tree Planting- Letters sent out-Awaiting quotations.

Burial Ground-Mowing contract has been given to M Parkinson with effect from 1st October 2012. FOI request has been received for information relating to 2004. Ledger and accounts that have been located show one entry in this respect. Email the details. Solicitors has requested all recent correspondence to be sent to him for a response to be prepared. Annual inspection to be carried out on Memorials at end of September 2012.

Mowing- Amenity Mowing-Clerk and Chair to prepare a specification for amenity mowing to ensure that all areas are covered in village. Awaiting details of Highways mowing.

SWDP- Largely no objections to the application, however, the only access to Holly Close is through Ivy Lane therefore there is no easy route to village. This could be resolved by providing access to Station Road at the end of the dead end part of application. Regarding full planning application for development of 48 dwellings, including 19 affordable

units, open space & associated infrastructure on land north of Station Rd, Bretforton.

Bretforton Parish Council has the following comments to make:

- The planning application is premature as the SWDP has not yet been approved and is still in consultation period.
- The development is too large when taken in conjunction with development at Holly Close, ref; W/01519/PN.
- Bretforton would like to see the removal of the affordable housing as this has already been accommodated at Holly Close thus bringing the number back in line with original figure.
- If approved the PC would like phasing to be a condition over a period of time thus reducing the impact of 2 developments which we feel is unreasonable.
- Bretforton PC wishes that conditions such as; restrictions on times that workforce can work, no parking on roads around development and a wheel wash to ensure roads are kept clear.
- Bretforton has no objections to the layout.

Audit Commission- Notification has been received to confirm new external auditors. **Rooftop Housing-** Letter received from Rooftop stating that there were no conditions attached to sale re parking of caravans. Matter resolved-see above.
